## 4.1 Proposed Standing Committee Terms of Reference Template

The GAESC Committee gave feedback on proposed Standing Committee Terms of Reference (ToR) template and recommended the following requirements be included in the ToR:

- a) External Agency Reps or Members at Large can be appointed to Standing Committees however this is not currently common practice,
- b) Council members are the only voting members of Standing Committees,
- c) Mayor maintains the authority to appoint Standing Committees members as required,
- d) Council members of Standing Committees are appointed for a two-year term and can be reappointed with no term limit,
- e) Cadence of a Standing Committee is determined by a Standing Committee,
- f) Every Standing Committee needs to appoint a Vice Chair who perform the responsibilities of the Chair if the Chair is unavailable,
- g) Standing Committee members will participate in a biennial self-evaluation process to reflect on their collective performance, identify areas for improvement, and take proactive steps to enhance the Committee's effectiveness and impact.
