Staff updated GAESC on the Committee Review Project. Major developments in the last quarter included:

- Provided training to all members of the three new Committees in person at Municipal Hall
- Three new Committees have had their first meetings
- Committee Operating Guide is 90% complete
- Working with Communications to get the training on the website for onboarding of future new members
- Working to get the remaining Standing and Select Committees on the new template – these will come to Council in the first half of this year for approval
- E-scribe training for Recording Secretaries to transition all committees to using e-scribe
- The pre-meetings between the Chair, Staff Liaison, CAO are happening online and the Mayor requested to attend those meetings.

The Committee discussed the use of Artificial Intelligence (AI) and that the RMOW needs an AI strategy before we start to embed AI into our day-to-day operations and that this was a 2026 deliverable.

4.4 Council Self-Evaluation Update

Staff updated the GAESC regarding the Council Self-Evaluation update.

- After the 2024 Self-Evaluation process was completed, GAESC asked that the survey questions be updated to shift the focus away from the staff relationship and towards driving improvements and best practices for high performing boards.
- Now that Roles and Responsibilities training is complete, we would like to revisit the survey and put it on the Work Plan

Proposed next steps are for staff to:

- Research best practices from other Councils and communities.
- Simplify and clarify the questions based on feedback.
- Prepare a draft of the revised questionnaire for this group's review and circulate to the Committee members before the March 2025 GAESC meeting for feedback.
