This category applies to unfinished cuts of gypsum that were never installed (also called "Disposal Instructions: • Gypsum must be available for inspection by attendant prior to unloading	cut offs").
2. POST 1990 GYPSUM

This category applies to gypsum that is known to have been installed after December 31, 1989 and is date stamped or accompanied by lab results that confirms it does not contain asbestos. It is widely accepted that construction materials manufactured after this date do not contain asbestos.

Disposal Instructions:

- · Signed declaration form required
- No pre-approval required
- Materials may be disposed of normally in accordance to site regulations

3. PRE 1990 GYPSUM, NOT TESTED FOR ASBESTOS (residents/ homeowners with small quantities only)

This category applies to gypsum from residents/ homeowners only where a hazard assessment has not been completed (not tested for asbestos) and the gypsum is known to have been installed before January 1st, 1990, OR where the origin and age of the gypsum are unknown.

Disposal Instructions:

- · Signed declaration form required
- No pre-approval required
- · Materials must be double-bagged and sealed in plastic bags that are at least 6 ml thick (0.006 inches) before arriving at a disposal facility
- · Loads are restricted to maximum of ten (10) bags per resident per day, four (4) times per year.
- · Loads only accepted from residents/ homeowners
- Pre 1990 gypsum from commercial/ businesses will not be accepted
- · Material must be deposited in the appropriate location as directed by site attendants and in accordance with all site regulations

4. PRE 1990 TESTED AND CONFIRMED TO NOT CONTAIN ASBESTOS

This category applies to disposal of gypsum originating from buildings where a hazard assessment has been completed and lab results have confirmed the waste gypsum does NOT contain asbestos.

- · Signed declaration form required
- · Hazard assessment (including lab results) must be attached to declaration form. Lab results older than six months are not accepted.
- · Materials may be disposed of normally in accordance to site regulations

PLEASE READ CAREFULLY - By completing and signing this form, you:

- 1. Understand and agree that asbestos is a hazardous material found in many construction materials installed pre-1990 (examples include Gypsum wall board (drywall), wall tape, and drywall mud compound, plaster and plaster board, vinyl floor tile and leveling compound, ceiling tiles cement pipe, stucco and cement siding, spray applied insulation and attic insulation) that if handled or processed improperly poses a serious health risk to workers and the public exposed to asbestos-contaminated air:
- 2. Affirm that you have made a truthful declaration about the origin, age and content of the material you are delivering and dumping at this facility;
- 3. Agree to accept liability fo, and indemnify the facility operator against, all costs, claims, damages, liability, fees, penalties, offenses, fines, expenses incurred by the facility operator that may result from an incorrect or truthful declaration regarding the origin, age and content of the material you are delivering and dumping at the facility.
- 4. Agree to adhere to all disposal instructions (both written and verbal), and you may be subject to an offence and penalties under the Environmental Management Act.
- 5. Understand that the facility operator may conduct samples of waste materials to ensure you have made a truthful declaration. If it is found you have made an incorrect or untruthful declaration you will be liable for all costs associated with the clean-up, remediation, and proper disposal of the waste materials. This may include but is not limited to the costs of emergency hazardous waste clean-up that could result from a positive asbestos sample in a load of pre 1990 gypsum.
